- Helton Defibrillator. GC checked on defib and seems in good order.
- Prevent long articulated vehicles coming around the corner at Askham Bridge. Clerk to email issue to Lowther PC as it's on their patch.
- Grass cutting/wildlife area (previously discussed), dog fouling and cats. CW reports that residents that have problems with nuisance cats have to deter the cats themselves (sprays/scarers/repellers etc), have a word with the owners of the cats and if not resolved Eden District Council can be contacted.
- Cycleway/Footway from Askham to Helton. If the current one is not fit to use then there is an alternative (and safer) option of going via Whale. The 2 Billion pound grant that will be rolled out by government is not aimed at rural areas but towns and cities to take the strain off public transport.
