110. MINUTES

The minutes of the meeting held on Monday 22nd July 2020 (Via Zoom) were approved as a correct record.

111. DECLARATION OF INTEREST/DISPENSATION: G Calland in OFP.

112. PUBLIC OPEN FORUM:

D Bliss on parking. Entire Lake District been inundated with tourists and although Askham tourist number have increased, we have not experienced negative impact of destruction as seen in other areas of the LDNP. D Bliss suggests a voucher scheme for local residents to park at Old Mill. Tourists don't want to pay £2 to park and chose to park elsewhere for free. Suggested that relevant signs are erected to prevent tourist parking in inappropriate areas. J Banks suggest to add 'where to park' not just 'no parking' signs. Outside church is common land and suggested that 'church parking only' signs go up. D Bliss states that it's unfavourable for Lowther to stop people from parking on Helton common as visitors enjoy the walks and views from Helton. The do however realise that it potentially damages the land for commoners, but feels that the PC can address this matter if they wish.

N Hughes on Minibus Route from P Bridge to Lowther would be great and would relieve parking issues. Electric cars not the short-term solution for the LDNP.

S Thomas on footpath between Askham & Helton. The ageing Helton community has a great need for a safe footpath to walk to shop incl mobility scooter use. Large family groups also use the path and can be dangerous with heavy farm traffic and cars driving too fast. Looking in to the possibility on approaching landowner and creating a safe footpath. D Bliss advises to contact Tirril community as they have just worked together (alongside ERT) to create a new walkway. There might be funding available. C Whitaker to work with S Thomas on proposal to create options for new/safer path.

N Hughes: Unitarisation of Cumbria to move to a single tier government had previously been tried and not convinced it will happen this time. Blueprint to come

out pre Christmas. LH states that if Unitarisation happens then parish councillors will have to get formal training on things like planning.
